## 賽員須知

賽事將主要以 IFSC 賽例 2021 為藍本。但比賽場次、時間及入圍人數,將依據參賽人數而有所更改,並以比賽當日裁判長之宣佈為準。

- (1) 賽員有責任自行熟讀賽例。

- (2) 賽員必須穿著大會指定之出賽背心。
- (3) 賽員須要自行保管號碼布供所有比賽日使用。
- (4) 賽員須自備個人器材,包括安全帶、攀石鞋、粉袋等。如有需要,可向大會租用安全帶,費用\$50,請於 報到時向工作人員提出。
- (5) 所有上訴(「技術事故」例外)·必須在該項賽事成績公佈後五分鐘內(初賽)及二分鐘內(決賽)以書面提出及向大會繳交**港幣伍佰圓**之上訴費。如上訴得值·上訴費會發還予上訴人。
- (6) 上訴事項會由賽事統籌、裁判長及副裁判長處理,作出最終裁決。
- (7) 如有需要,副裁判長可代替裁判長之職務。
- (8) 賽員必須遵守工作人員的指示。
- (9) 請保持場地清潔。
- (10) 注意個人防疫措施,以減低病毒傳播風險。
- (11) 任何違返規則或指示的賽員,均可能會被發黃牌/紅牌警告。
- (12) 大會只購買第三者保險,如有需要,賽員須自行購買個人之參賽保險。
- (13) 如天文台在比賽當日早上七時發出紅色、黑色暴雨、八號風球或以上之訊號,當日賽事將會取消。
- (14) 如環保署公佈空氣質素健康指數為(7) / (8-10) / (10+)·即健康風險級別為「高」/「甚高」/「嚴重」時· 賽事將如常舉行。由於空氣污染對不同人士的影響不一·如有疑問或感到不適·宜徵詢醫生的意見。
- (15) 有關比賽的一切事宜,以大會的最終判決為準。

## 32nd Hong Kong Sport Climbing Open Competition Event Information

- (1) The IFSC International Rules 2021 will be applied in this competition. However, the number of rounds, climbing time and quota shall be adjusted according to the number of participants enrolled. The Jury President will announce the final decision on the day of competition.
- (2) All competitors have the responsibility to study thoroughly the competition rules: IFSC Rules 2021: <a href="https://cdn.ifsc-climbing.org/images/World\_Competitions/2021\_IFSC\_Rules\_v176.pdf">https://cdn.ifsc-climbing.org/images/World\_Competitions/2021\_IFSC\_Rules\_v176.pdf</a>
- (3) All competitors must wear the competition white vest.
- (4) All competitors are required to keep their own no. bib for both competition days.
- (5) All competitors must bring their own climbing equipment, i.e. harness, climbing shoes, chalk bag etc.. Harness is available with rental fee of HK\$50 if needed, please indicate during registration.
- (6) Any appeal (except technical incident) against the published result shall be raised within 5 minutes (Qualification) and 2 minutes (Final) of the publication of the Official Results by written form together with an appeal fee of **HK\$500**. If an appeal is upheld, the appeal fee shall be returned. If an appeal is rejected, the appeal fee shall not be returned.
- (7) The Technical Organizer together with Jury President and Deputy Jury President shall make the final decision of any appeal.
- (8) Deputy Jury President would take up the duty of Jury President when necessary.
- (9) Competitors must comply with all the instructions given by event officials.
- (10) Please keep the venue clean and tidy.
- (11) In order to reduce the risk of virus spreading, each participant should pay attention for personal measurement of epidemic prevention.
- (12) A yellow or red card warning will be given to competitors who violate the rules or guidelines.
- (13) A third-party insurance shall cover the competition. Competitors may seek for their own personal insurance if necessary.
- (14) When the Red, Black Rainstorm Signal, Typhoon No. 8 or above signal is issued at 7:00am, the competition on that day will be cancelled.
- (15) IF the Air Quality Health Index in Hong Kong is high (7), very high (8-10) and serious (10+), the competition will be run as scheduled. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.
- (16) All affairs related to the competition will be determined & finalized by the panel only.
