Purpose : To offer participants of the Sport Climbing Programme under the School Sports Programme (SSP) an opportunity to exchange skills and to participate in competition with a view to enhancing their interest in sport climbing as well as their skill levels.

Date : Explorer – 15 Feb 2025 (Sat)
Open – 16 Feb 2025 (Sun)

Time : 8:00am - 6:00pm

Venue : Tsuen Wan Sports Centre – Outdoor Sport Climbing Wall

Targets : Priority will be given to primary and secondary schools which have previously joined the Sport Climbing Programme under the SSP. Applications from other primary and secondary schools will also be considered if the quota is not filled. Participants should be current student of the school during the competition.

- a. Each student may represent for one school and participate in one category only.
- b. Each school may enter a maximum of 4 students for each division.
- c. Members of Hong Kong Representative Team (Lead+Boulder) and Youth Athletes Sport Climbing / Competition Climbing Training Scheme during 2022 to 2025 and previously won any prize at Hong Kong, China Mountaineering and Climbing Union (HKCMCU)'s difficulty climbing competitions are not allowed to participant in the Explorer Categories.
- d. School is advised to arrange participants' names in the Application Form in the order of priority for the competition. If the number of applications exceeds the quota, places will be allocated according to the school's priority in the Application Form.
- e. Organizer reserves the right to adjust the quota for each division with reference to the enrolment response. The participants should have no objection.

Fees : \$100 per participant

- Enrolment and enquires :
- a. Each school should submit the completed Application Form and Parent/Guardian Consent Form together with a cheque in person or by post (payable to the “Hong Kong, China Mountaineering and Climbing Union Ltd.” with the school name marked clearly on the back) for payment of the total amount of its participants' enrolment fees to the Hong Kong, China Mountaineering and Climbing Union, Room 1013, Olympic House, 1 Stadium Path, So Kon Po, Causeway Bay, Hong Kong **from now to 14/1/2025** (the postmark date will be regarded as the submission date). The cheques may be returned to schools not enrolled.
 - b. Every participant should sign the “**Participant's Declaration of 2025 Sport Climbing Competition**”. Participant aged below 18 should provide a declaration signed by his/her parent or guardian before taking part in the competition.
 - c. Once the enrolment form is submitted, any change of information is not allowed.
 - d. Any application with incomplete / wrong information, sent by fax, or submitted late will not be accepted.
 - e. Unsuccessful applicants will not receive any notification.
 - f. If the number of participants in a division is less than 4, the Organizer reserves the right to transfer them to a higher division or cancel the division concerned.
 - g. Applicants will receive the “Acknowledgement Receipt” from the Hong Kong, China Mountaineering and Climbing Union. If no Acknowledgement Receipt is received before **12:00 pm, 28/1/2025**, please contact our staff at 2504 8125. Otherwise we may not be able to process your application;
 - h. The admission list will be uploaded on the Hong Kong, China Mountaineering and Climbing Union Limited website on **7/2/2025**. Please access to the website: www.chkmcu.org.hk

- Note to participants :
- a. Note to participants and event schedule will be uploaded on the organizer website: www.chkmcu.org.hk on 7/2/2025. Participants must browse on their own.
 - b. “Harness” will be provided by the Organizer.
 - c. Participants have to wear school sportswear and arrange their own food and drink.
 - d. Participants cannot enter into the competition venue five days before the day of the event.
 - e. All participants **must wear climbing shoes during competition** and can **only** wear the climbing shoes in designated area.
 - f. The Organiser will carry out photo shoots/video-filming/arrange broadcasting during the competitions, and has the right to display/publish the event photos or videos on the Internet, at venues of the Leisure and Cultural Services Department, on the dedicated website, in publications of the Organiser and through other publicity channels, for promotion of activities or record purposes.

- g. All participants must comply with the house rules of the Competition venue and the competition regulation of the Organizer.
- Appeal :
- No appeal will be accepted. The judges’ decision on the competition results shall be final.
- Awards :
- a. Prizes and certificates will be awarded to the Champion, 1st runner-up and 2nd runner-up in each division. For those divisions less than 5 participants, prize and certificate will only be awarded to the Champion.
 - b. The School Team Championship will be awarded to the school with the highest score. Details are listed below:
 1. The Champion, 1st runner-up and 2nd runner-up in each division will have 3, 2 and 1 mark respectively.
 2. To sum up the marks for each division, the school with the highest accumulated mark will be awarded the School Team Championship.
 - c. Certificates of Attendance will be issued to all participants as encouragement.
- Inclement weather :
- a. If Tropical Cyclone Warning Signal No. 3 or above, or Yellow /Red / Black Rainstorm Warning signal has been issued by the Hong Kong Observatory or Environmental Protection Department announces the Air Quality Health Index (AQHI) reaches 10+ (i.e. the “serious” health risk level) at the General Station of the affected district where the match is being held, or Education Bureau had made announcement on closure of schools 2 hours before the commencement of the first match on the competition day, all matches on that day will be **cancelled**. Participants will be notified of the subsequent arrangement in due course.
 - b. If the AHQI reaches 10+ (i.e. the “serious” health risk level) at the General Station of the affected district where the match is being held, all matches in progress at that district should be **stopped immediately**.
 - c. In case of inclement weather or issuance of any of the above warning signals during the competition, the Organizer reserves the right to revise the competition schedule or cancel the competition in progress.
